- B13 Deletion of condition in its entirety.
- B16 Deletion of condition in its entirety.
- B19 Move to Section E Prior to Occupation Certificate.
- B21 Move to Section E Prior to Occupation Certificate.
- E5 Deletion of condition in its entirety.
- Reword the heading of Section B to read as follows: "Prior to Issue of the relevant Construction Certificate".
