In response to matters raised during public submissions, the panel advised Council to undertake an audit of compliance with previous conditions of consent.

6. Business Item Recommendations

Moved Mark Grayson, seconded Sandra McCarthy that approval be granted for the expansion and upgrade of the Jamberoo Action Park, Lot 3, DP258919, Lot 1, DP1070506, 1215 Jamberoo Road Curramore with deferred commencement conditions.

MOTION CARRIED

Moved Mark Grayson, seconded Michael Forsyth that:

1 Condition (6) Car Parking and Vehicular Access on page 46 be deleted;

- 2 reference to the development site in Condition (1) under the heading Construction is amended to read construction site, not development site;
- 3 reference to the Construction Certificate in Condition (1) under the heading Ground Water Bores and Monitoring be amended to read Occupation Certificate, not Construction Certificate;
- 4 condition (2) under Traffic Management on page 42 be amended to read as follows:-

The Operational Traffic Management Plan shall be reviewed and audited by a consultant traffic engineer following the seasonal closure of the Jamberoo Action Park. The independently audited report shall be submitted to the Kiama Local Traffic Committee for assessment within a period of three (3) months of the seasonal closure of the Jamberoo Park operations and the recommendations of the Kiama Local Traffic Committee shall be implemented.

- 5 Condition 1 under the heading Landscaping Works shall be amended to require additional planting along the western boundary of the car park, and the detailed landscape plan to be prepared by a qualified Landscape Architect;
- 6 delete the reference to overflow carparking area in Conditions (3) and (5) under the heading Operation of Recycled Waste Water Irrigation Areas and Standards and delete conditions (7) and (8) under this heading; and
- 7 include a condition requiring all buildings and structures be of a recessive colour.
