4 Business Item

ITEM 1 – 2011STH012 Wollongong City Council DA-2011/437 – Proposed Upgrade to Crown Street Mall, Wollongong

This matter was previously discussed by JRPP at its meeting of 5 August 2011.

Independent planning consultant Jeff Mead gave an updated overview of the proposed upgrade of works. A Public Information session has been held and the matter went before Council on 12 December 2011. Part of that resolution from Council reads that the design for the Crown Street Mall refurbishment, prepared by the Government Architect's Office, be adopted and that the Joint Regional Planning Panel be requested to determine the current development application.

Andrew Carfield advised that the final detail of a plan for the Mall is still being looked at however; Council is to revisit a number of matters including the type of trees proposed. Residents can write to the Councillors and state their issues.

7. ***ITEM 2 – 2011STH016 Wollongong City Council DA-2011/718 – Demolition of existing structures and construction of residential flat building Lot A DP 415263, Lot B DP 415263 and Lot 2 DP 331687 32-34 Church Street, Wollongong.***

Councillor Dorahy and David Winterbottom attended the meeting.

This matter was previously discussed by JRPP at its meeting 2 December 2011 and was deferred to enable assessment of the heritage significance.

The site is not heritage listed however the property contains archaeological foundations of a very early Illawarra residence “Bustle Hall”.

Council Officer Joel Thompson advised that the NSW Heritage Inventory is not up to date. The listing for No 32 Church Street was removed from the Local Environmental Plan as it

was recognized that an error had been made, however it was not removed from the heritage listing.

9. Business Item Recommendations

- 1 The Panel defer the application to enable a further independent comprehensive assessment to assess the heritage significance of No. 34 Church Street and its gardens.
- 2 The archaeological remains of Bustle Hall be listed in the Wollongong Local Environmental Plan.
- 3 Council pursue grant funding to update the 1991 community heritage study that considers nominations for assessment of additional buildings and places.
