1. The Panel resolves unanimously to accept the recommendation of the planning assessment report to approve the application, for the reasons mentioned in the report and subject to the conditions recommended in the report, except as noted below.
2.
  - 2.1. In Condition 12 “the Council’s Director of City Planning” is substituted by “Certifying Authority”;
  - 2.2. Condition 16 is amended to require ceiling fans in the living rooms of the 25 apartments identified as not having through ventilation;
  - 2.3. Condition 40 is deleted; and
  - 2.4. In Condition 53 the words “relevant to the Lot 11 development site” are added after “Stage 1 works”.
3. Councillor Matson accepted the SEPP 1 justification for the FSR non-compliance on the basis of the density control plan of the Court-approved Little Bay Stage 1 Master Plan.
