ITEM 1 - 2011SYE087 – North Sydney – DA115/11 - Demolition of an existing heritage listed residential flat building containing eight units and construction of a new six (6) storey residential flat building comprising five units, two levels of basement parking for 8 cars and associated excavation, road works and landscape works. - 106 Kirribilli Avenue, Kirribilli

- The Panel resolves unanimously that it will approve the application subject to a satisfactory set of conditions including a condition that requires the existing sandstone, if demolished, to be reinstated and repaired as required. The side wall of the garage entry is to be sandstone faced.
- 2) The Panel's reasons for approval are:
  - (a) the overwhelming weight of professional opinion supports the assessment of the heritage significance of the existing building as minor; and
  - (b) the design quality of the replacement building is high and is supported by the council's Design Excellence Panel.
- 3) Michel Reymond voted to impose a condition to reduce the depth of the balconies from 2.8m to 2m; however, this was not supported by the majority.
- 4) The council's planning assessment officer is requested to produce a set of appropriate conditions by 19 December 2011. The applicant is requested to comment on the conditions by 21 December 2011. Following this, the Panel will make a decision by electronic means of communication.
