Dear Panel Members

Council is in receipt of a referral response from the NSW Rural Fire Service regarding the above development application which has been referred to you for determination.

The assessment report, which was completed prior to the referral response being received, includes commentary to the effect that:

"A referral response from the NSWRFS has not been received to date but it is anticipated that, given the similarities between the proposed development and DA2011/1025 and the condition of vegetation on the site, the referral response will be similar.

In this regard, the NSWRFS did not raise any objection to the previous development subject to conditions which addressed the appropriate design of buildings and require the development to comply with the principles of Appendix 5 of 'Planning for Bush Fire Protection 2006'.

Notwithstanding, once received the updated referral response will be provided although it should be noted that the response will not change Council's recommendation for the refusal of this application."

This memo informs the Panel that the referral response has been received, that it is consistent with the above advice and does not raise any objection to the proposal subject to conditions which are to be imposed should this application be approved.

Notwithstanding, as noted in the above assessment report commentary, the response does not change Council's recommendation for the refusal of this application.

Land Use Application for 42 Myoora Road Terrey Hills NSW 2084

I refer to your letter dated 28 March 2012 seeking advice regarding bush fire protection for the above Land Use Application in accordance with Section 79BA of the 'Environmental Planning and Assessment Act 1979'.

The Service provides the following recommended conditions:

Water and Utilities

The intent of measures is to provide adequate services of water for the protection of buildings during and after the passage of a bush fire, and to locate gas and electricity so as not to contribute to the risk of fire to a building. To achieve this, the following conditions shall apply:

1. Water, electricity and gas are to comply with section 4.1.3 of 'Planning for Bush Fire Protection 2006'.

Design and Construction

The intent of measures is that buildings are designed and constructed to withstand the potential impacts of bush fire attack. To achieve this, the following conditions shall apply:

- New construction of the warehouse shall comply with Australian Standard AS3959-2009 'Construction of buildings in bush fire-prone areas' section 5 (BAL 12.5) and section A3.7 of Addendum Appendix 3 of 'Planning for Bush Fire Protection 2006'.
- 3. New construction of the Resaurant/cafe has no requirements in regard to Australian Standard AS3959-2009 'Construction of buildings in bush fire-prone areas'.

Landscaping

4. Landscaping to the site is to comply with the principles of Appendix 5 of 'Planning for Bush Fire Protection 2006'.
