Add to condition 2.20 D018 – Underground Tanks after:

"Inlets to underground storage tanks are to be located so as to ensure that vehicles discharging fuel are contained within the boundaries of the site."

The following:

"The underground storage tanks to be installed in accordance with the relevant Australian Standards: -

AS1940 - Storage and Handling of Flammable and Combustible Liquids; and AS4897 - The design, installation and operation of underground petroleum storage systems."

Add to condition 2.45 L001 - General Landscaping to read:

"A landscape plan prepared by a consultant registered with Penrith Council shall be submitted to the principal certifying authority prior to the issue of a construction certificate. All landscape works are to be constructed in accordance with that plan and Sections F5 "Planting Techniques", F8 "Quality Assurance Standards", F9 "Site Management Plan" of Penrith Council's Landscape Development Control Plan. That plan shall also address the management of the biodiversity corridor on site.

Landscaping and the biodiversity corridor shall be maintained:

- *in accordance with the approved plan, and*
- in a healthy state, and
- in perpetuity by the existing or future owners and occupiers of the property.

If any of the vegetation comprising that landscaping dies or is removed, it is to be replaced with vegetation of the same species and, to the greatest extent practicable, the same maturity, as the vegetation which died or was removed."

Add **condition 2.64** as follows:

"Additional parking spaces, if required, shall be made available to the satisfaction of Council"
