# PowerPoint Presentation by Kerry Robertson of Landcom

The presentation outlined Landcom's unilateral offer and provided their comparison of this approach with Council's proposed conditions and full contributions payable under the WELL Precinct Plan without a \$30,000 cap. \$53,000 per lot plus \$30,000 per lot and additional works equals \$94,000 per lot.

The Panel discussed the matters raised with the Landcom representatives present and Council Staff.

The Panel indicated that they are not in a position to make a determination nor refer the matter to the Minister based on current information. They requested more information in relation to the application of S94 contributions including details of those items addressed in the Council's recommendation and in the offer of Landcom, the implications of the \$30,000 cap on the feasibility of developing the private lands within this precinct.
