### "46. Hours of Operation (Reviewable Condition)

The approved hours of operation for the use of the following areas of the premises are restricted as follows:

(a) Beer Garden and Functions Terrace:

Monday to Sunday: 9.00am to 12.00 midnight

(b) Noodle Bar and Outdoor Gaming Area

Monday to Wednesday:	9.00am to 2.00am
Thursday to Saturday:	9.00am to 3.30am
Sunday:	9.00am to 3.00am

In accordance with Section 80A (10B) of the Environmental Planning and Assessment Act, 1979, Condition 46 is a reviewable condition and Council may review the condition at any time. Upon the condition being reviewed the operating hours may be varied in accordance with the recommendations of the review. The purpose of the reviewable condition is to enable the extended operating hours to be reviewed should they be subject to complaints regarding noise or other disorderly or antisocial behaviour."

2. The JRPP recommends that Council's Traffic Committee review the current traffic movements to and from the site, particularly vehicular egress for right turn movements out of the site on to Edensor Road. Such a review should consider current and future traffic conditions on Edensor Road and whether there is a need for any additional traffic measures to be imposed to ensure adequate safety.
