6. The Panel's Decision

Item 1 - 2012SYW040 - Ku-ring-gai - DA0058/12 - Demolition of redundant buildings, consolidation of lots and construction of a 54 bed dementia facility between 3 and 4 stories - 2-12 Neringah Avenue South; 3 - 9 Woonona Avenue, Wahroonga

The Panel unanimously approved this application for the reasons given in the Council Planning Assessment Report and subject to the minor amendments to proposed conditions attached to that report. The approved conditions are attached to the minutes.

Item 2 - 2011SYW046 - Ku-ring-gai - DA0147/11 - Realignment and reconfiguration of Killara Golf Course including new water storage dam - 556 Pacific Highway Killara

The Panel unanimously agrees to approve the application for the reasons given in the Council Town Planning Report subject to the additional conditions attached to the minutes:

It is to be noted that Cr Malicki does not support the proposed removal of the Eucalypts on the boundary of Fairways 6 and 7.

Additional Conditions

1. The centre of the new green on Hole 2 must be a minimum distance of 65m from the rear boundary of the nearest residence in Mildura St.
2. In addition to the retention of the existing safety screen, an additional safety screen is to be provided along the length of the tees for Hole 2 and to meet the specifications given in Option 1 of the Golf by Design of April 2012 (on page 6).
3. Hours of operation of any mechanical or noise generating machinery on Hole 2 will be limited to before 8am or after 8pm on any Sunday or public holiday, or before 7am or after 8pm on any other day, in accordance with Clause 50 of the Protection of the Environment Operations (Noise Control) Regulation 2008.

Kauri Pines adjacent to Fairway 15 (trees H15-107, H15-108)

Cypress Pines and Himalayan Cedar adjacent to Green 11 (trees H11-1, H11-2, H11-3, H11-4, H11-5, H11-6, H11-7, H11-8, H11-9)

Accept removal of

Jacaranda and Himalayan Cedar adjacent to Fairway 18 (trees H18-155, H18-156)

Eucalyptus trees adjacent to Green 14 (trees H14-103 and H14-104)

5. The landscaping proposed adjacent to the rear boundaries of properties 1 – 21 Gleneagles Avenue, Killara is to be deleted.
