Hi Darren,

I won't be able to response to you in writing until the end of week, but in principle APA Group approved under the following requirements:

- Risk Assessment supplied by Council is followed
- Final plans are sent for review
- Erosion caused by the Facility will not be the responsibility of APA Group sufficient cover must be kept at all times for the protection of the pipeline
- No vibrating rollers to be used in the vicinity of the pipeline easement and a list of equipment etc is to be sent prior to working over the easement
- Notification of at lease 1 week must be provided prior to working over the pipeline easement, APA require that we have a representative on site at all times
- If any further protection measures are required they will be at the cost of Bathurst Regional Council.

Subject Bathurst Bike Park Comments

Hi Darren,

I've reviewed both the feasibility study, SEE and noise assessment and offer the following comments. These comments are effectively my own and have been provided to assist you progress this matter. They have not been reviewed by Office of Environment and Heritage (OEH) management. Should you seek formal comment from OEH you should write to this office and ask as much. I understand that this development is yet to be 'assessed' by Council's planners under the EP&A Act.

- The proposed Bike Park is not a Scheduled Activity under the *Protection of the Environment Operations Act 1997* and as such will not require and Environment Protection Licence. Being a Council owned facility however, OEH would be the appropriate regulatory authority for environmental issues during both construction and operation.
- Based on the information provided, I can see no reason why the operations of both the BikeParkand the OMYA Plant would impact upon each other from an environmental perspective (air, noise, surface water) during the course of normal day to day activities. I can envisage that there may be the potential for noise disturbance from OMYA to any office/meeting room facilities established within the Bike Park unless this building has been appropriately sited and/or constructed with due regard to noise insulation.
- Transport conflicts (with OMYA) are most likely the biggest issue for the proposed facility although this is not a matter for OEH.
- I agree with the recommendations of your Flora/Fauna consultant with regard to the White Box, Yellow Box, Blakely's Red Gum Endangered Ecological Community as discussed in Section 7 of the SEE the remnant vegetation should be avoided with appropriate 'sympathetic' fencing and signage utilised to keep cyclists out of this area.
- I note that there has been no assessment of Aboriginal cultural heritage. While the site has been extensively modified from its original pre-European settlement days there is still the potential for artefacts and other cultural heritage vaslues to exist on site. Council should consider engaging an appropriate professional in consultation with the local Bathurst Aboriginal Land Council to conduct a survey of

the site.

I trust that these comments are of assistance to you.
