Proposed Bathurst Bicycle Park

I refer to your letter dated 6 August 2011 regarding the development of a Bicycle Park to be located on Vale Road, Bathurst.

In relation to your concerns expressed about the level crossing, Council agrees that if required, any required upgrade would be at the full cost of Bathurst Regional Council. It should be noted that the primary vehicular entry to the bike park will be from College Road which should ameliorate the concerns relating to the level crossing. Council acknowledges your concern regarding the potential queuing of vehicles across the level crossing and additional warning signs as appropriate will be installed to deter this behaviour. The car park has been designed to allow sufficient on site queuing capacity upon entry and it is considered that there is satisfactory queuing length between Vale Road and the level crossing upon exit of the Bicycle Park. Council has engaged the services of a specialist traffic engineering firm to confirm this.

It is acknowledged that excavation depths are limited to a maximum of 2m within 25m of the rail corridor by the State Environment Planning Policy (Infrastructure) 2007 Clause 86. At this preliminary design stage, there is no intention to require excavation to be greater than 2m. It is understood that further approval would be required through an additional development application if this excavation depth was to be exceeded.

It would be appreciated if you could advise of your approval regarding this project at your earliest convenience.
