5. Panel Decision

Item 1 - 2012HCC020 - Gosford - 42409/2012 - Extractive Industry 5 Staged development, Lot 2 DP 362339 No 620 Wisemans Ferry Rd Somersby

- A. The Joint Regional Planning Panel as consent authority refuses Development Application No 42409/2012 for a proposed Extractive Industry 5 Stages Designated / Integrated Development on LOT: 2 DP: 362339, 620 Wisemans Ferry Road SOMERSBY for the following reasons:
 - 1. The Development Application contains inadequate information to assess air quality impacts, and impact on adjoining resident/human health, particularly by PM_{2.5} and PM₁₀ crystalline silica.
 - 2. The Development Application contains inadequate information to assess the impact on groundwater resources.
 - 3. The impact of the proposal on an Aboriginal artefact and potential impact on Aboriginal Cultural Heritage.
 - 4. The potential impact of the proposal on the amenity of adjoining and nearby residents, particularly in relation to air quality impacts.
 - 5. The Development Application has not satisfactorily addressed Clause 7(2) of Sydney Regional Environmental Plan No 8 in relation to future suitable agricultural land uses.
 - 6. The proposal is inconsistent with the objectives of the 1(a) Zone, particularly objective (f).
 - 7. It is not clear whether the Director General's environmental assessment requirements have been complied with by the applicant, particularly in relation to community consultation.
- B. It is noted that General Terms of Approval have not been issued by the Environment Protection Authority nor by the NSW Office of Water. It is also noted that while an application has not been made as Integrated Development under the National Parks and Wildlife Act 1974, an approval under s90 of that Act is required.
- C. The applicant is to be advised of the Panel's decision and of their right to appeal to the Land and Environment Court within six (6) months after the date of determination.
- D. The people who lodged submissions and relevant agencies are to be notified by the council of the decision.
