That the recommendation in the officers report for DA-2012/405 be adopted subject to the following changes:

A Amendments to Existing Conditions

Condition 9: Add the following sentence:

(j) Should ongoing monitoring be required by the site auditor a Section 88E positive covenant needs to be registered on title reflecting requirements on all affected future lots.

Condition 56: Add the following sentence:

Removable bollards are to be installed in the emergency access road to restrict everyday vehicular access

Condition 177: Add the following sentences:

- (f) (i) A positive covenant detailing any ongoing monitoring requirements (if required) by the site auditor.
- (j): A restriction as to use over any lots affected by the containment cell advising of relevant restrictions to use and building arising from the remediation of the site and any requirements of the Operational Environmental Management Plan.

B Additional Conditions

76A: Operational and Environmental Management Plan (OEMP)

The preparation of an OEMP that identifies:

- i) specialised work methods to be followed during construction of building and works on the containment cell,
- ii) ongoing maintenance and management requirements for each lot affected by the containment cell.

139A: Access to adjoining lands

Vehicular access to the Bulli Showground, Bowling Club and Tennis Club shall be maintained during the course of the development works.

191: Additional Conditions to DA-2010/968

Pursuant to Section 80A(1)(b) of the *Environmental Planning & Assessment Act*, 1979, development consent DA-2010/968 be modified to include conditions 128 and 129 and formal notice be forwarded to Council in accordance with Clause 97 of the *Environmental Planning & Assessment (EP&A) Regulation 2000* prior to the commencement of any works.

192 Consistency between plans

No approval is granted or implied for any future residential development as shown as point 12 on Landscape plan LMO4A prepared by Taylor Brammer.

193 Access to the Tennis Club

A detailed engineering and landscape Plan for vehicular and pedestrian access on the southern side of the tennis club and courts is to be prepared and submitted to Council for approval prior to the commencement of any works. Works are to be carried out in accordance with the approved plans and in conjunction with the main entry access roadworks and roundabout north of the existing tennis court and must be completed prior to the issue of any subdivision certificate and be undertaken at the applicants expense.

C Deletion of Conditions

Deletion of Condition 137.
