  - Preliminary Geotechical Investigation, Coffey Geotechnics, 8 June 2011
- (b) The reference in Schedule 1 Application Documentation to Landscape Plan prepared by Somewhere Landscape Architects be amended to refer to Plan No. L01 Rev C dated 27 June 2012
- (c) The addition of the following conditions:
  - (i) The development is to comply with all relevant recommendations contained in the application documentation provided in Schedule 1.

 (ii) Landscape works are to make allowance for Council to replace the existing footpath on the nature strip at the front of the hospital with a new 2 metre wide shared path. Consideration should be given to planting low water usage native species in landscaped areas.
