Condition 1 to be amended to read as follows:

1a A Traffic Management Plan to apply during construction works be submitted to Council for endorsement prior to commencement of works.

Condition 7 to be amended to read as follows:

7 Prior to the commencement of electrical and telecommunications works satisfactory arrangements for Essential Energy and the relevant telecommunications authority, for both the provision of electrical power and telephone lines respectively, to fully service the development, shall be made.

REASON: To ensure electrical power and telephone lines are available to service the development. Section 79C(1)(b) of the *Environmental Planning and Assessment Act 1979*, as amended.

Condition 23 to be amended to read as follows:

23 Offset plantings shall be carried out within close proximity to the development and in accordance with the requirements for Asset Protection Zones to compensate the removal of the eucalyptus melliodora trees. A ratio of 20 to 1 local native trees shall be planted totalling 200 trees. Particular attention is to be given to planting to screen the subject development and neighbouring heritage items.

Representatives of the applicant were in attendance at the meeting and agreed to the changes to the conditions of consent.
