- The Panel resolves by a majority of 4 to 1 (for: John Roseth, David Furlong, Sue Francis and Scott Nash; against: Murray Matson) to accept the recommendation of the planning assessment report to approve the application, for the reasons listed in the report and subject to the conditions recommended in the report, except as follows:
 - a) Deferred Commencement Condition 1 becomes a standard condition with the last sentence deleted;
 - b) Deferred Commencement Condition 2 is deleted;
 - c) Deferred Commencement Condition becomes a standard condition with the phrase "are to be submitted to council approval" deleted;
 - d) A new condition is inserted requiring "left in- left out only" to and from the car park, by the use of an appropriate traffic facility to the satisfaction of council's traffic engineer;
 - e) In addition to the above changes, the conditions should be rationalised without changing their content or intent.
- 2) The Panel gave careful consideration to the concerns of objectors; however, it reached the conclusion that, with the lowering of the tower building, the proposal's impacts were acceptable. In addition, the Panel gave major weight to the social benefits of the application.
- 3) Murray Matson voted against approval because he wanted one additional floor removed from the tower building in order to be consistent with the previous consent.

The meeting concluded at 7.50pm.
