5. **Business Item Recommendations**

***ITEM 1 - 2012SYE104 – Canterbury - 390-2012 - 2 Vermont Crescent,
Riverwood & 13 Washington Avenue, Riverwood***

- 1) The Panel resolves unanimously that it will approve the application subject to a suitable set of conditions yet to be prepared, and subject to the following changes to the proposal:
 - a) the garbage rooms of the educational establishment and of the residential component shall be switched, with a sketch to be submitted by the applicant; and
 - b) fourteen at-level parking spaces and an additional four spaces in the street shall be provided for the use of the educational establishment.
- 2) The reasons for the Panel not accepting the recommendation of the planning assessment report to refuse the application are:

- a) the switch of the garbage rooms overcomes the problem of handling garbage disposal, nominated in the assessment report as one of the two main grounds for refusal; and
 - b) in the Panel's opinion, the applicant's amended proposal, which provides 14 spaces for users of the educational establishment, is adequate (thus responding to the second of the two main reasons for refusal).
 - c) It follows from the above that the Panel believes that no further spaces within the car park are required for the users of the educational establishment.
- 3) The Panel requests
- a) the applicant to submit to council a sketch of the switched garbage rooms by 18 March 2013;
 - b) the planning assessment officer to prepare a set of draft conditions by 22 March 2013;
 - c) the applicant to comment on the draft conditions by 28 March 2013;; and
 - d) the planning assessment officer to prepare a short supplementary report by 5 April 2013.
- 4) Following receipt of the supplementary report the Panel will determined the application by communicating by electronic means.
