ITEM 1 - 2012SYE118 – Rockdale - DA-2013/164 - Demolition of existing structures and construction of a two storey residential aged care facility comprising 143 beds and basement car parking - 1-7 Eddystone Road, 17 Rye Ave and 104-110 Stoney Creek Road Bexley

 The Panel resolves unanimously to accept the recommendation of the planning assessment report to approve the application, for the reasons mentioned in the report and subject to the conditions recommended in the report, with a new second sentence being added to condition 21(iv) as follows:

" The proposed opening shall be replaced by a window with a minimum sill height of 1.2 metres."

- 2. In arriving at its decision the Panel has considered the matters raised by the residents of Rye Avenue and notes that a number of those issues have been addressed in the proposed conditions of consent.
- 3. In relation to the concerns raised about traffic and parking in Rye Avenue, the Panel would request that Council give consideration to:
 - a) Reminding the Council Depot staff to park in the allocated car park, rather than parking in Rye Avenue; and
 - b) The overall traffic circumstances of the Precinct surrounding the site be monitored.
- 4. The Panel also notes further advice provided to it, that the issue of parking in Rye Avenue has recently been referred to the Council's Traffic Engineering staff for consideration.
