## 2012SYW065 - The Hills, 1336/2012/JP, Mixed Use Development, 2-4 Barry Road, North Kellyville

# 2012SYW029 - The Hills - DA854/2012/JP - Proposed Apartment Buildings (133 Units), Integrated Housing (35 Dwellings) and Neighbourhood Shop, 75 - 95 President Road, Kellyville

This application has been before the Panel on a previous occasion when it was deferred because of some irregularities in neighbour notification. Proper notification has now been given, but during the adjournment the applicant offered to make some changes to the design following comments by the Panel. These changes were minor in nature but, if approved, would bring about a better outcome in design and improved amenity for neighbouring sites.

Whilst there were some objections to the form and design of this development, the Panel notes that the suite of controls which the council has imposed on this site has anticipated such a form of development. The application deals appropriately with the R2 and R3 zonings and has provided suitable amenity for the incoming residents and existing residents alike, so that the Panel agrees with the council's planning report that the application should now be approved subject to conditions.

The Panel unanimously approves the application for the reasons given in the planning report and subject to the conditions suggested by Council Planners, which are attached to the minutes.
