### **4. The Panel's Resolution**

The panel unanimously resolved to approve the development applicant subject to the conditions contained in the memorandum from Parramatta City Council dated 13 December 2012 which had conditions agreed with the applicant subject to the following amendments:

Condition 3A be altered to read:

- 3A. *Pursuant to section 93I(3) of the Environmental Planning & Assessment Act 1979, the applicant must enter into a planning agreement in terms of the offer set out in the letter dated 21 December 2010 from Frasers Morton Pty Ltd to Council and will carry out the works as per the VPA as registered on the legal title of the site. Nothing in this consent derogates from the rights and obligations conferred by the planning agreement.*

**Reason:** *To ensure performance of obligations under a planning agreement*

Condition 85 be altered to read:

*85. Noise from the construction, excavation and/or demolition activities associated with the development shall comply with the NSW Department of Environment and Conservation's Interim Noise construction Guidelines 2009.*

**Reason:** *To protect the amenity of the area.*

## **7. The Panel's Resolution**

The panel unanimously resolved to approve the development applicant subject to the conditions contained in the assessment report as updated in the memorandum from Parramatta City Council dated 13 December 2012 that had been agreed by the applicant subject to the following amendments.

Condition 30 be altered to read:

### **Public Arts Plan**

*30.A Public Arts Plan, prepared in consultation with Council and in accordance with part 3.4.1 of the Parramatta DCP 2011 shall be submitted to the satisfaction of Council's Public Art Officer prior to the issue of the Construction Certificate for the proposed building works on proposed Lot 3. This Plan is to be prepared in conjunction with the owners of proposed Lot 1.*

Condition 31 be altered to read:

### **Works to Victoria Road Pursuant to DA 709/2011**

*31.The proposed modification to the signalised intersection on Victoria Road to service the site shall be approved by RMS and the Work Authorisation Deed (WAD) is to be executed prior to issue of the occupation certificate for any works within the site.*

Condition 32 be altered to read:

### **Acoustic Report**

*32. A further acoustic report is to be prepared and submitted to the Principal Certifying Authority prior to issue of the Construction Certificate requiring an acoustic assessment of all plant and mechanical services and the provision of plans showing the acoustic treatment of the plant room in accordance with the acoustic attenuation treatment recommended in section 6.9 'Mechanical Noise' of Noise Impact Assessment Report prepared by Acoustic Logic, (Project Number 20120135.1 & document reference 20120135.1/0309A/R4/JS) dated 3 September 2012.*
