### 5. Panel's Decision

**Item 1 -** 2012SYW093 - Ku-ring-gai - DA0378/12 - Demolish existing structures and construct 2 residential flat buildings containing 86 units, basement parking and landscaping, 5-15 Lamond Drive, Turramurra

The Panel unanimously agreed to defer determining the application for additional information to be supplied by 20 July 2013 as follows:

- 1. Satisfactory demonstration by the applicant of its position regarding ventilation, sunlight to units, 3 hours of sunlight in midwinter to open space, the number of underground units and their amenity and environmental performance.
- 2. Provision of additional information on the following matters -
  - Geotechnical report on the absorption area to provide water to the lower trees,
  - Structural details of the stormwater pipes above the proposed driveway tunnel,
  - Demonstration of the practicality of servicing the deep stormwater pits and functioning of the 90 degree bend in stormwater system on the northwest side of the site.
  - The validity of the applicant's expert conclusions on the impact on the Blue Gum High Forest on the site.
  - Explanation of the changes proposed to the right of way-will it allow unfettered use in accordance with the terms of the easement.
- 3. Provision of additional detail in the vegetation management plan.
- 4. Amended plans showing the manner in which the application comply with clauses 25L, 25N, 25I(2) of the Ku ring gai Planning Scheme Ordinance.
- 5. Specification where retaining walls should be placed in relation to unit walls.
- 6. Confirmation of the capacity of downstream stormwater drainage system to accommodate the anticipated post development flows.

Council is asked to assess the additional information it holds on the 20 July 2013 and advise the panel when it will be in a position to present its further report.

At the next meeting of the panel both Council and the Applicant are requested to have their relevant experts present to assist the panel.

**Item 2 -** 2013SYW020 - Ku-ring-gai - DA0489/12 - New multi purpose sports hall, car park and sports field - Abbotsleigh school - Heritage property, 1670 Pacific Highway, Wahroonga

The Panel unanimously approves the application for the reasons outlined in Council's Town Planning Report, subject to the conditions contained therein with amendments to the conditions as discussed at the meeting and noting the acceptance by the applicant's representatives. The amended conditions are attached to the Minutes.

The Panel was asked by a representative of the Owner's Corporation of Strata Plan 77814 (Beumont apartments) questions regarding enforcement of conditions of

consent. This is a responsibility of the local council and the regional panel has no power to dictate to the Council the manner in which it will enforce compliance with conditions. In regard to the general concern about traffic conditions in the local streets, the panel recommends the residents take this matter up directly with the Council. The Panel further notes that, in regard to the request from the Corporation for access to School's further reports and plans for this application the Headmistress gave an undertaking to provide this documents, and to undertake a management plan regarding the traffic and operation of the new facilities.

The Panel notes the co-operation of the Owner's Corporation, the applicant and the Council in conditioning this application which has brought about a satisfactory outcome.
