STATEMENT OF REASONS **for decision under the *Environmental Planning and Assessment Act 1979*** **(NSW)**

The Northern Joint Regional Planning Panel (JRPP) provides the following Statement of Reasons for its decision under section 80 of the *Environmental Planning and Assessment Act 1979* (NSW)(the Act) to:

Grant consent to the development application subject to conditions

for:

Proposed Extractive Industry (Sand Quarry) Newrybar Swamp Road, Lennox Head

Council Ref: DA 2013/162 - JRPP Ref: 2013NTH007

Type of regional development:

The development is referred to the JRPP under Schedule 4A clause 8 *particular designated development* of the Act. The proposal is classified as extractive industries:

Extractive industries, which meet the requirements for designated development under clause 19 of Schedule 3 to the Environmental Planning and Assessment Regulations 2000.

The development constitutes an integrated development pursuant to Section 91 of the EP&A Act 1979. The required approvals are:

A Controlled Activity approval under Part 3, Chapter 3 of the Water Management Act 2000 - issued by the Office of Water

An Environmental Protection Licence under the Protection of the Environment Operations Act 1997 – issued by the Environment Protection Authority.

2. JRPP as consent authority

Pursuant to s 23G(1) of the Act, the Northern Joint Planning Panel (the Panel), which covers the Ballina Shire Council area, was constituted by the Minister.

The functions of the Panel include any of a council's functions as a consent authority as are conferred upon it by an environmental planning instrument [s23G(2)(a) of the Act], which in this case is the *State Environment Planning Policy (State and Regional Development) 2011*.

Schedule 4A of the Act sets out development for which joint regional planning panels may be authorised to exercise consent authority functions of councils.

3. *Procedural background*

A site visit and final briefing was undertaken by Garry West, Pamela Westing, John Griffin, David Wright and Steve Barnier on 19 March 2014. The site inspection included council staff and the applicant/owner.

B. Evidence or other material on which findings are based

C. Findings on material questions of fact

The Panel has carefully considered all of the material referred to in Section B.



D. Why the decision was made

- In light of the Panel's findings in Section C, the Panel decided to grant consent to the development application, subject to the amended conditions submitted by Council at the Panel meeting.
- The amended conditions address the concerns raised by the public with the exception of the visual amenity. After consideration of the submissions, the panel felt that the visual amenity did not require any further action.
