***ITEM 1 - 2032STH003 – Goulburn Mulwaree Council – DA/0245/1213 – Designated development for Waste Management Facilities or works (Recycling facility) – 54 Sinclair Street, Goulburn***

Motion:

- A) That approval be granted to Development Application No. 245/1213/DA for a proposed Waste Management Facilities (Recycling Facility) at 54 Sinclair Street, Goulburn, subject to conditions of consent as drafted and incorporating changed conditions 2 and 42 as follows:

Condition 2.

- a. Consent is granted to utilise part of the site to receive, sort, compact, temporary store and distribute by road approximately 8,000 tonnes per year of recyclable material from kerb side collection in Goulburn Mulwaree Shire. Any significant intensification of this quantity or type of activity carried out on site will require the separate approval of Council.
- b. The recyclable material comprises glass, paper, cardboard, plastics, steel and aluminium cans.
- c. No putrescibles or liquid trade waste will be handled on site.

Condition 42.

The owner of the building shall ensure that the building and site is maintained in a clean and tidy manner at all times.

- B) The JRPP recommends that Council consider installing additional traffic management measures at the intersection of Common and Sinclair Streets given the volume of vehicle movements to be generated from the development.
