Re: Integrated Development Referral – General Terms of Approval Dev Ref: DA13/0307 Description of proposed activity: Extension of Existing Tarcoola Quarry Site location: 2 Gillard Rd, East Wagga Wagga, NSW, 2650

I refer to your recent letter regarding an integrated Development Application (DA) proposed for the subject property. Attached, please find the Office of Water's General Terms of Approval (GTA) for works requiring approvals under the *Water Management Act 2000* and the *Water Act 1912*, as detailed in the subject DA.

Please note Council's statutory obligations under section 91A (3) of the *Environmental Planning and Assessment Act 1979* (EPA Act) which requires a consent, granted by a consent authority, to be consistent with the general terms of any approval proposed to be granted by the approval body.

If the proposed development is approved by Council, the Office of Water requests that these GTA be included (in their entirety) in Council's development consent. Please also note the following:

- The Office of Water should be notified if any plans or documents are amended and these
 amendments significantly change the proposed development or result in additional works on
 waterfront land (which includes the bed of any river together with any land within 40 metres
 inland of the highest bank of the river), or any amendments to accessing water supply works
 for the proposed development.
- Once notified, the Office of Water will ascertain if the amended plans require review or variation/s to the GTA. This requirement applies even if the proposed works are part of Council's proposed consent conditions and do not appear in the original documentation.

- The Office of Water should be notified if Council receives an application to modify the development consent and the modifications change any activities on waterfront land.
- The Office of Water requests notification of any legal challenge to the consent.

Any application for the construction or modification of a flood control works must include a flood study for the subject area. This flood study must detail the potential impacts on any neighbouring properties, infrastructure and the environment. This flood study must be submitted with the flood control works application.

As the controlled activity to be carried out on waterfront land cannot commence before the applicant applies for and obtains a controlled activity approval, the Office of Water recommends the following condition be included in the development consent:

"The Construction Certificate will not be issued over any part of the site requiring a controlled activity approval until a copy of the approval has been provided to Council".

The attached GTA are not the approvals. The applicant must apply (to the Office of Water) for any approvals after consent has been issued by Council and before the commencement of any work or activity on waterfront land.

Finalisation of approvals can take up to twelve (12) weeks from the date the Office of Water receives all documentation (to its satisfaction). Applicants must complete and submit (to the undersigned) an application form for a new or amended controlled activity approval, a flood control works approval, a water use approval, a water supply works approval or a water access licence together with any required plans, documents, the appropriate fee and security deposit or bank guarantee (if required by the Office or Water) and proof of Council's development consent.

The Office of Water requests that Council provide a copy of this letter to the applicant.

The Office of Water also requests that Council provides the Office of Water with a copy of the determination for this development application as required under section 91A (6) of the EPA Act.

12	All works involving soil or vegetation disturbance shall be undertaken with adequate measures to prevent soil erosion and the entry of sediments into any river, lake, waterbody, wetland or groundwater system.		
13	The destruction of trees or native vegetation shall be restricted to the minimum necessary to complete the works.		
14	All vegetation clearing must be authorised under the Native Vegetation Act 2003, if applicable.		
15	The approval to be granted may specify any precautions considered necessary to prevent the pollution of surface water or groundwater by petroleum products or other hazardous materials used in the construction and/or operation of the works.		
16	A fee calculated in accordance with the Water Management Act 2000 must be paid before an app can be granted.	proval
