## 5. Business Item Recommendations

ITEM 1 - 2013SYE001 – Pittwater - N0353/12 - Oceanvale -Stage 2 of Multi-Unit Housing Development - 79 - 91 MacPherson Street, Warriewood (Formerly known as 14-18 Boondah Road, Warriewood) - 79-91 Macpherson St, Warriewood

- The majority of the Panel (for: John Roseth, David Furlong and Sue Francis; against: Kylie Ferguson and Selena Griffith) resolves to accept the recommendation of the planning assessment report to approve the application, for the reasons mentioned in the report and subject to the conditions recommended in the report except as follows:
  - a. Those conditions that were agreed by the applicant and the assessment officer to be varied are amended as indicated in Steve Evans' email of 15 April 2013.
  - b. The deferred commencement conditions are deleted.
  - c. A new Part B is created with the heading "Matters to be addressed before the lodgement of an application for Construction Certificate for any aboveground works". Into this Part are inserted the proposed Deferred Commencement Condition No 2 and proposed Conditions C9, C10 and C11. Following condition C11 the following is inserted "All required plans and reports are to be submitted to Council for its approval."
  - d. Proposed Part B becomes Part C and all subsequent Parts are moved back by one letter.
  - e. The heading of proposed Part C (new Part D) is amended by deleting the words *"the Construction Certificate"* and replacing them with the words *"any Construction Certificate"*.
- 2. The majority of the Panel, which approved the proposal, has listened carefully to the objectors who believe that the proposal is too dense and bulky for its location. However, the Panel is aware that, as long as the proposal is consistent with the approved Concept Plan, the Panel has no power to require a reduction in density or bulk.
- 3. Councillors Ferguson and Griffith voted to refuse the application because they have concerns with the whole process, as the built outcome is so different from the existing Warriewood Valley Plan.
