**DILAPIDATION SURVEYS OF NEIGHBOURING BUILDINGS – DRAFT DA CONDITION NO.7
PROPOSED BUNNINGS WAREHOUSE
CNR. KINGSGROVE RD AND RICHLAND ST, KINGSGROVE, NSW**

This letter addresses Council's draft DA Condition 7 regarding dilapidation reports on neighbouring building to the proposed Bunnings development, which involves some below ground excavation. The supplied drawing (Drawing NO. 01030_DA201, Revision 01, Dated 13/11/13) prepared by C&M, indicates that the lowest basement (B2) level to be at RL28.9m AHD. This will require maximum excavation depth of about 10.6m at the north western corner, 4.1m at the south western corner, 1.1m at the south eastern corner and 4.4m at the north eastern corner of the site.

On Section 4.2 page 8 of the JK Geotechnics geotechnical report (Ref. 25343V2rpt-Consolidated-Konsgrove dated 26 September 2013), it is clearly stated that dilapidation survey should be completed only on neighbouring buildings that fall within the influence zone of the excavation.

This excavation zone of influence is defined as twice the depth of the excavation.

Below is a table summarising which property warrants a dilapidation survey based on the supplied information.
