## 5. Panel Decision

**Item 1 - 2012SYW114 – Parramatta - DA/750/2012, Demolition, tree removal and construction of a part 4 and part 7 storey residential flat building complex, containing 95 apartments and a neighbourhood, 76 - 84 Railway Terrace & 1 -3a Mombri Street and a portion of the Railway Terrace road reserve in front of the site, Merrylands**

The Panel unanimously approves the application for the reasons outlined in Council's Town Planning Report, subject to the conditions contained therein with an amendment to the condition 10 (a) as discussed at the meeting and noting the acceptance by the applicant's representatives.

The amended condition 10(a) to read as follows:

- The provision of additional visitor parking spaces must be submitted in accordance with requirements of Council's DCP or otherwise to the satisfaction of Council's Service Manager Traffic and Transport, even if this should lead to reduction of deep soil landscaped areas.

**Item 2 - 2013SYW003 – Parramatta - DA/694/2011/A, Section 96(2) modification to an approved nineteen storey mixed used development, 109 - 113 George Street, Parramatta**

The Panel unanimously approves the modification application for the reasons given in the council planning report subject to the council's suggested conditions.

**Item 3 - 2013SYW055 – Parramatta - DA/634/2012, Demolition, tree removal and construction of a two storey apartment building containing 10 apartments under the Seniors Living SEPP. 8-12 Bungaree Road, Toongabbie**

The Panel unanimously approves the application, for the reasons given in the council report and subject to the council's proposed conditions.

The Panel further considers the development would:

- Have a positive impact on the character of the built environment and be consistent with the future character of the locality as it undergoes renewal;
- Serve the public interest by increasing the supply of affordable housing in the local government area and Western Sydney;
- Have minimal impact on the amenity of the surrounding residential area, and
- Well located in regards to transport services and neighbourhood facilities.

**Item 4 - 2012SYW095 – Parramatta - DA/587/2012, Alterations to a Heritage Building, Approval is also sought for demolition, tree removal and construction of a 13 storey mixed use development, 64-68a Phillip Street, Parramatta**

The Panel unanimously approves this modification application for the reasons given in the council planning report subject to the council's proposed conditions with 2 additional conditions relating to protection of the Heritage Building, and Construction Noise as follows:

### **Protection of the Heritage Building**

The Heritage Building on the subject site is to be protected from damage during the construction works by way of hoardings and enclosure to protect from falling debris, construction damage and construction vehicles on the site. The protection measures are to be

formulated in consultation with the site foreman and applicant's heritage architect to the satisfaction of Council's heritage advisor. Such measures are to be agreed prior to the release of the construction certificate and maintained until the completion of all building works.

### **Construction Noise**

Noise emissions and vibration must be minimised and work is to be carried out in accordance with the NSW Department of Environment, Climate Change and Water Interim Noise Construction Guidelines 2009 for noise emissions from demolition, excavation and construction activities.

Vibration levels resulting from demolition and excavation activities shall not exceed 5mm/sec peak particle velocity (PPV) when measured at the footing of any nearby building.

**Reason:** to maintain appropriate amenity to nearby occupants.
