MODIFICATION APPLICATION NO. 533.2/2012 JOINT REGIONAL PLANNING PANEL NO. 2013SYW087

PROPERTY:

Lot 102 DP 1034345, No. 561-583 Polding Street, Prairiewood

DESCRIPTION OF DEVELOPMENT:

Alterations and additions to Stockland Wetherill Park Shopping Centre comprising 5,664m² of additional gross leaseable floor area (GLFA) located at ground level and three (3) levels of deck car parking above, and associated works (Stage 2).

The subject Section 96(2) Modification Application proposing to modify DA No. 533.2/2012, which includes amendments to the approved building elevations and internal layout, provision of a supermarket replacing the existing Franklins and previously proposed 'mini major' store, amendments to the approved carpark layout and extension to the construction hours at Stocklands Shopping Centre, is recommended for approval. Accordingly, Development Consent 533.2/2012 has been amended as follows:

1. Condition No. 1 is amended to read as follows:

2. Condition No. 25 is amended to read as follows:

25. During Construction or Demolition

During the construction or demolition period, the applicant must ensure that any building work is to be carried out within the following hours.

- Monday to Friday: between 7.00am and 6.00pm and Saturday between 8.00am to 3.00pm in all zones. No work may be carried out on Sundays or public holidays.
- Activities which don't cause 'offensive noise' as defined by the Protection of the Environment Operations Act 1997 can take place outside the above hours.

Note: On the spot penalties up to \$1,500 will be issued for any non-compliance with this requirement.

Condition No. 45 is amended to read as follows:

45. Landscaping to be Completed

The provision and maintenance of landscaping in accordance with the approved landscape plan prepared by Stockland, Drawing Number DA501-B, Issue B dated 1 August 2013, including the engagement of a suitably qualified landscape consultant/contractor for landscaping works.

4. Condition No. 46 is amended to read as follows:

46. Carparking

The following car parking shall be provided in accordance with Chapter 12 of the Fairfield City Wide Development Control Plan, 2013:

- a. 2637 off-street car parking spaces for staff and visitors; including
- b. 53 off-street car parking spaces for disabled persons (minimum width 3.8m).

Each space shall be permanently line marked and maintained free from obstruction at all times. Staff, company and visitors vehicles shall be parked in the spaces provided on the subject premises and not on adjacent footway or landscaping areas.

5. Condition No. 60 has been added to now read as follows:

60. Car Wash Facility

Prior to the issue of a Construction Certificate, detailed site and internal floor plans of the carwash facility are to be submitted to and approved by Council, which demonstrates that the new car wash facility will not cause any contravention of the Protection of the Environment Operations Act 1997.

6. All other conditions of the subject consent remain unchanged.
