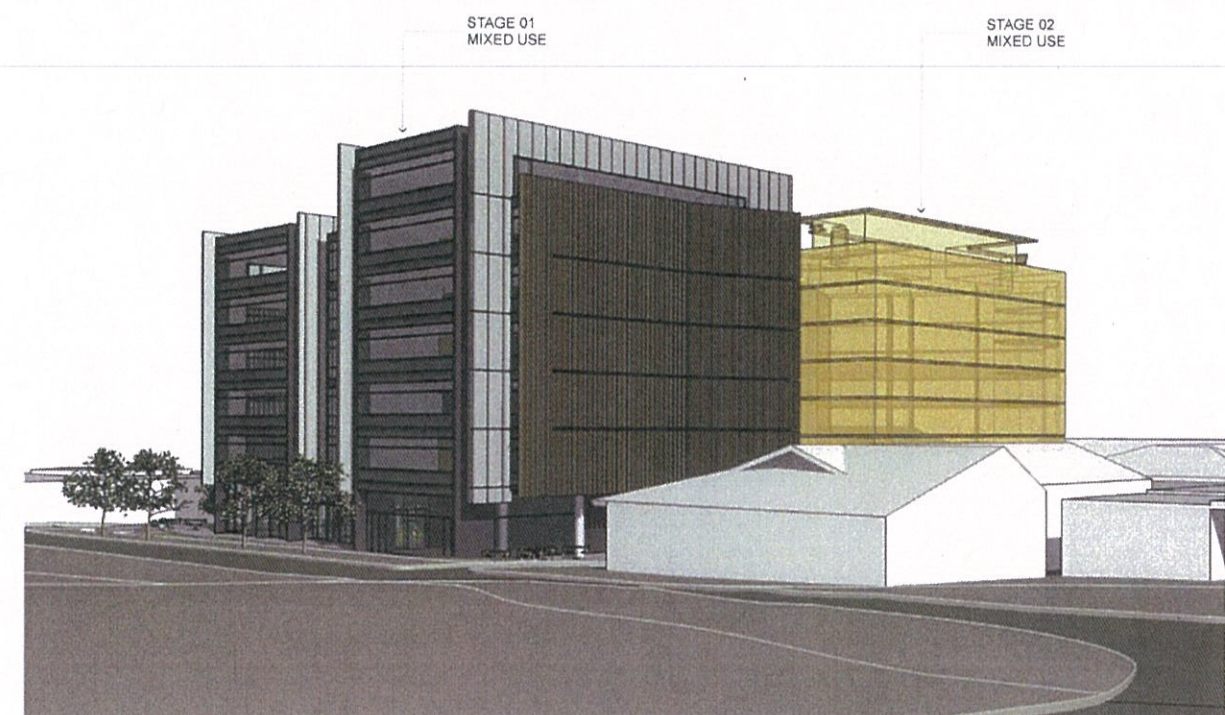

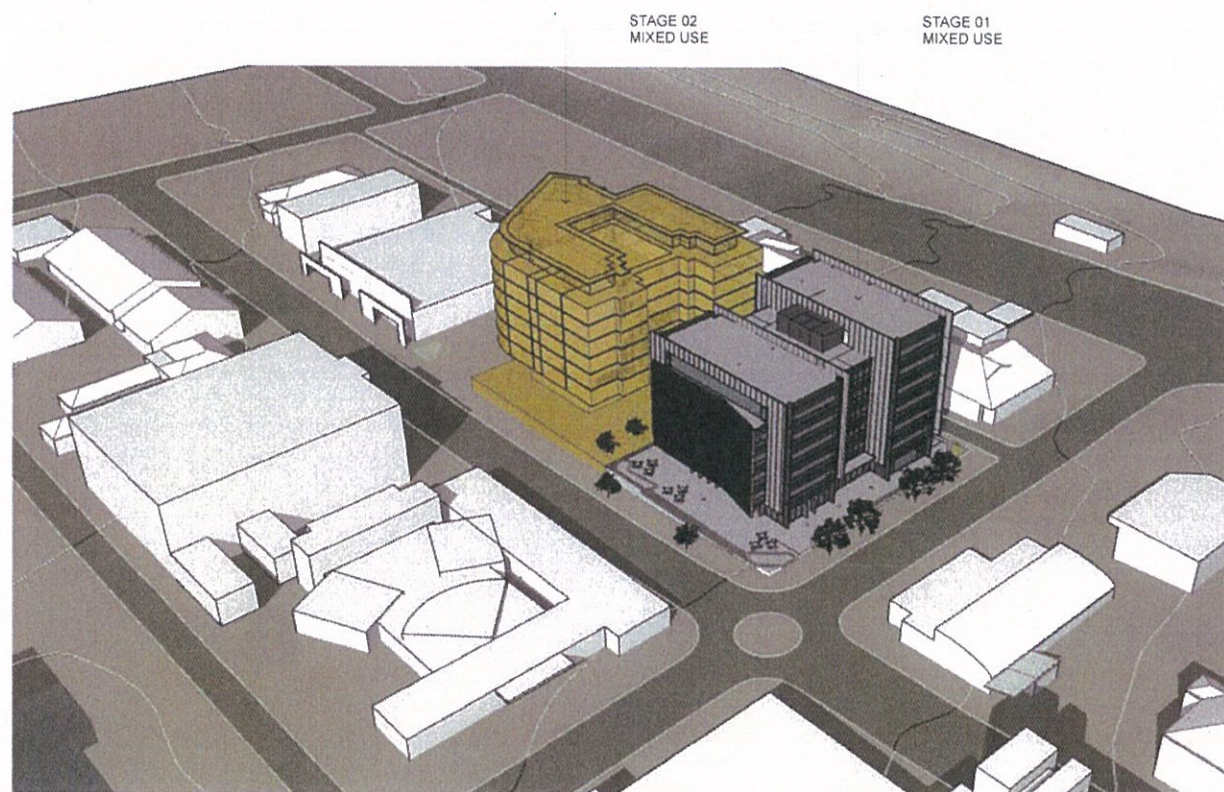




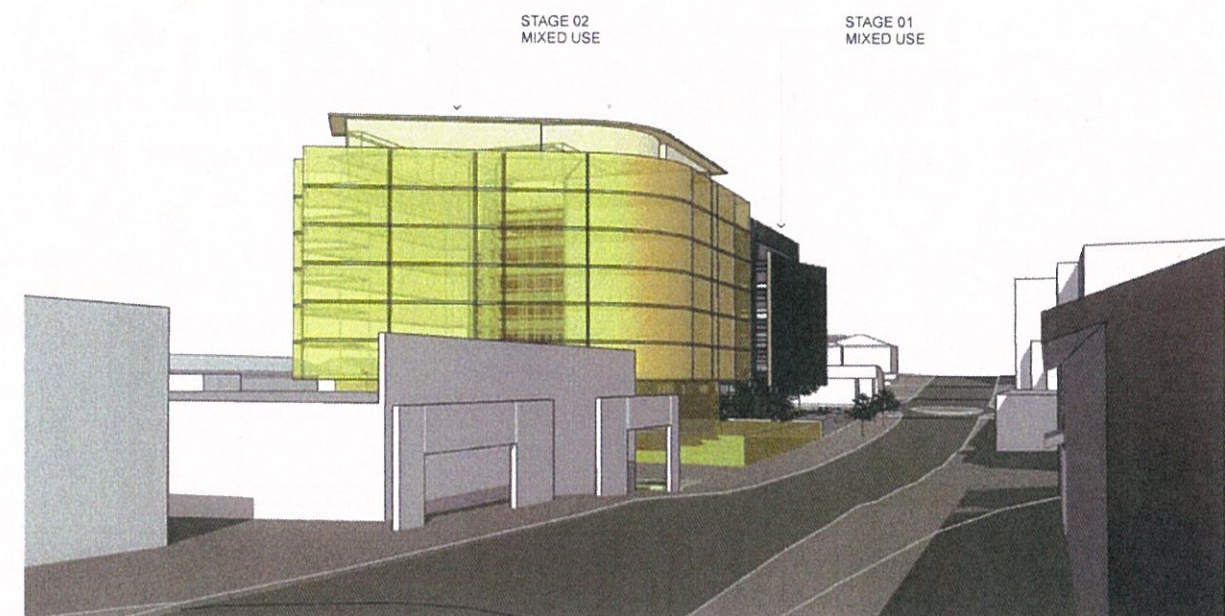
VIEW FROM CORNER OF HELY STREET AND ANZAC AVENUE



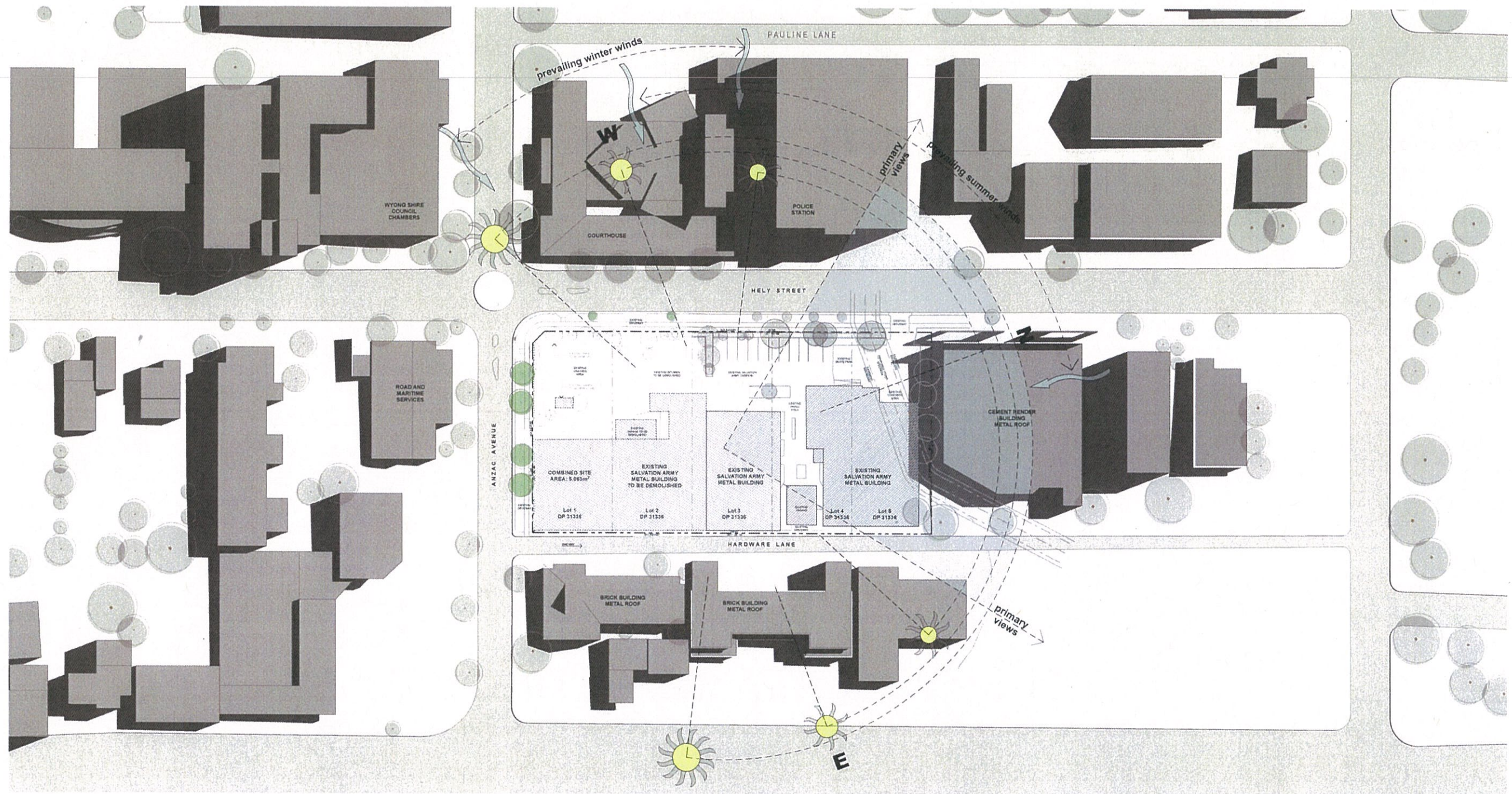
NORTHERN VIEW FROM HARDWARE LANE
