The panel determined to approve the development application as described in Schedule A pursuant to section 80 of the <i>Environmental Planning and Assessment Act 1979</i> .			
Panel consideration:			
The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.			
 Reasons for the panel decision: The panel adopted the assessment of those matters in the Council Assessment Report. The principal reason for the panel decision was that the development was in the public interest, utilising local resources to supply material to meet the needs of road construction for the Pacific Highway. Other reasons for the panel decision were: The quarry footprint was reduced to exclude any land within 150m of any existing residence; The quarry footprint was reduced to provide a minimum 50m setback from the northern boundary of Lots 186 and 187 DP 754400; The location of the internal access road was adjusted so that the construction is not closer than 140m to dwelling R5; and Conditions were approved to require the acquisition of 10 residences upon request in the event the development exceeds the environmental performance criteria in regard to noise, air quality and blasting. Conditions: The development application was approved subject to the conditions in Appendix A of the Council Assessment Report as amended at the meeting.
