Determination and Statement of Reasons

2014NTH018 Richmond Valley Council DA2015.069 [at Bungawalbin-Whiporie Road, Bungawalbin] as described in Schedule 1.

Date of determination: 20 May 2015

Decision:

The panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

Reasons for the panel decision:

The panel is satisfied the proposed development is consistent with the objectives of the zone within the Richmond Valley Council LEP and complies with the relevant State Environmental Planning Policies. The panel adopted the assessment of those matters in the Council Assessment Report.

The principal reason for the panel decision was that the anticipated impacts have been addressed through appropriate conditions of consent. Other reasons for the panel decision were: 1) Upgrading of the public road network is conditioned to address traffic related issues; 2) Total truck movements are limited to a maximum of 76 Monday – Friday and 22 on Saturdays as well being restricted from the route during school bus drop off and pick up times; 3) A biodiversity offset is proposed to the satisfaction of OEH and no vegetation removal can commence until the legally binding mechanism is approved to the satisfaction of Richmond Valley Council; and 4) Progressive rehabilitation is included within the Operational Plan of Management and the Soil and Water Management Plan and must be implemented to the satisfaction of Richmond Valley Council.

Conditions: The development application was approved subject to the conditions in Appendix A of the Council Assessment Report as amended. The panel adopts the Council Assessment Report and the recommended Conditions of Approval as amended, as the reasons for imposition of the conditions. The amendments are: Condition 3 removes the words "load" and inserts "truck movements"; Condition 27 is amended to clarify that Section 94 contributions will be allocated to the haul route roads. Condition 30 (17) is amended to provide flexibility in the standard of works required. Approved conditions are in Schedule B.
