### Determination and Statement of Reasons

**2014NTH022 - DA2014/183 – Nambucca Shire Council – Residential Aged Care Facility [Upper Warrell Creek Road, Macksville] as described in Schedule 1.**

**Date of determination:** Friday 30 January 2015

**Decision:**

The panel determined to approve the development application as described in Schedule A pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

**Panel consideration:**

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

**Reasons for the panel decision:**

The panel adopted the assessment of those matters in the Council Assessment Report.

The principal reason for the panel decision was that the proposed development complies with the relevant legislation and local policies ensuring that the public interest is maintained.

Other reasons for the panel decision were:

- (a) achieves the objectives of the Environmental Planning and Assessment Act 1979
- (b) complies with provision of all relevant Environmental Planning Instruments
- (c) is consistent with the aims and objectives of Council's Development Control Plans, Codes and Practices in that :
  - (i) it provides housing needs of varying types suitable for the particular community
  - (ii) provides for a transport service for residents given that the proposed development is more than 400m from facilities and services
- (d) The minor variation to the maximum building height under Clause 4.6 of the Nambucca Local Government Plan is accepted given to the building form integrating with the land form.
- (e) There is no significant impact on threatened species, populations or ecological communities or their inhabitants.

**Conditions:** The development application was approved subject to the conditions in the Schedule of Draft Conditions of the Council Assessment.
