
## Background

Further to our meeting of 19 February regarding outstanding DA issues, item 6 on QCC meeting notes records that QCC request GTPL consider amendment to Stage 5 large lot/fire trail edge to development area. GTPL understand that this arises from concern over the management of the fire trail, its grading in relation to RFS concerns, and effective access to bushfire fighting including from reticulated water. Additionally concern was earlier expressed by QCC on visual management of the rear of the large lots following concerns relating to similar lots elsewhere in Queanbeyan.

# **GTPL** response

GTPL has considered the concerns of QCC and RFS, and have redesigned Stage 5 accordingly to address the issues raised. The layout now resolves these issues, as follows and as shown below;

- Edge road to standard subdivision, allowing direct bushfire/reticulated water access. This road follows the alignment of the sewer based on the lowest sewer servicing limit.
- Small area of additional reserve between road and PTWL conservation area fence. QCC and GTPL to resolve detailed design and management of this area prior to issue of CC (the area continues the same condition proposed further South between street reserve and fenceline).
- PTWL conservation area fence now aligned to conservation area boundary, with some minor amendments to regularise the fenceline as noted below. The previous (DA) fenceline was located further West to form the rear fence of the large lots to the previously proposed firetrail.



# PTWL Conservation Area boundary & fence

As noted above the location of the fence/conservation area boundary has been regularized to allow for simplicity of alignment in the field. This accords to Table 3 of Section 4 of the PTWL-P&MP V5 under 'Establishment and boundary fencing (Stage 1)'; 'Precise boundary delineation to be determined during detailed design of the relevant section of Googong township.'

The relevant APZ (20/25/30m adjacent Stage 5) is taken from this fence which forms the APZ management boundary (noting that a 20m vegetation management zone also occurs within the PTWL area).

# **Consistency Assessment**

A letter is attached from Biosis confirming that the proposed layout and interface with the PTWL conservation area is consistent with:

- Googong Foreshores Interface Management Strategy, Version 3, Biosis, July 2014
- Pink-tailed Worm Lizard Protection and Management Plan (PTWL-P&MP Version
   5, Biosis July 2014

### Tree retention

All trees noted for retention in our recent letter of 03 March 2015 remain 'for retention' in this layout.

### RES

The plans submitted with this letter now remove the RFS concern over the firetrail and APZ's, as expressed in their letter of 24 December 2014.

# **Revised Plans for Approval**

Revised civil and subdivision plans are annexed to this letter for approval. They amend the layout, Lot/DP numbers and staging, noting some of the lots previously in Stage 5 are now able to be in Stage 2 due to amended civil design. GTPL request that the approval be for the submitted DA plans, except as amended by these drawings. A revised statement from the Registered Surveyor setting out the proposed subdivision will be provided to Council on 10 March.


