

## DA 183/2012

### Conditions of Consent Review by Clontarf Marina – 19<sup>th</sup> June 2014

ANS01 – Delivery times for fuel – **No issue.**

ANS02 – Decommissioning of the fuel tanks – **Issue.**

- Expert report recommends decommissioning and filling with concrete. Effectively, we will be left with two large concrete footings within steel formwork.
- Reason for Issue, excessive noise and disruption to Manly to Spit Walk during removal. Will block Sandy Bay Road. Decommissioning in place meets Legislation requirements.
- **Recommend complete decontamination and decommissioning insitu to current and relevant legislation.**

- Hardstand/slipway needs to use chemicals. ANS16 infers the permissibility of this use.
- Hardstand/slipway is the only EPA Draft Marina & Slipway Best Practice compliant facility on Middle Harbour.
- Hardstand/slipway fully bunded, spill protection, water filtration system.
- Aware that vessels over water cannot use chemicals for cleaning or defouling.
- **Recommend condition amended to “Under no circumstances can chemicals be used to wash or defoul vessels berthed at the floating marina. All vessel maintenance works requiring the use of chemicals to be completed over the existing hardstand.”**

- **Recommend removing condition restricting marina vessel operation times as this condition is inappropriate and unreasonable. What we propose is a Sydney and Middle Harbour industry standard supported by the RMS.**
