### **Determination and Statement of Reasons**

2014SYE148 Warringah DA2014/1290 [at Lot 100 DEP 1190199 Oliver Street, Freshwater] as described in Schedule 1.

Date of determination: 12 March 2015

#### Decision:

The panel determined to accept the recommendation of the assessment report to approve development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

#### Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

## Reasons for the panel decision:

The development of the school will replace some demountable buildings with permanent ones and improve the facilities of the school.

While the Panel accepts that removing teacher parking from the school grounds will inconvenience surrounding residents, the Traffic Management Plan required by Condition 30 will keep this impact to acceptable proportions.

**Conditions:** The development application was approved subject to the conditions in Appendix A of the Council Assessment Report as amended the Memorandum dated 11 March 2015. Condition 30 is further amended by changing:

- Part (d) to read Methods in which the school will provide parents and staff with education/information of legal parking areas around the school, exact locations of pick-up drop-off zones, and options for other ways to get to and from school; and
- Add a new paragraph The plan must be established and implemented with the input of a community reference group.
