The panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the Environmental Planning and Assessment Act 1979.

### Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

## Reasons for the panel decision:

- 1. The proposed development will add to the supply and choice of housing within the West Central Metropolitan Subregion in a location with ready access to the services and amenities offered by Mount Druitt Centre and to the regional and district transport facilities available at Mount Druitt station.
- 2. The scale and form of development is consistent with the planned future of the locality.
- 3. The proposed development adequately satisfies the relevant State Environmental Planning Policies including SEPP 65 and its associated Residential Flat Design Code.
- 4. The proposal complies with Blacktown LEP 1988 and Draft Blacktown LEP 2015.
- 5. The proposal adequately satisfies the provisions of Blacktown DCP 2006. In this regard the Panel notes that the building height exceeds that specified in the DCP. However, the proposal will be compliant with the requirements of the soon to be adopted Draft LEP 2015.
- 6. The proposed development will have no unacceptable impacts on the natural or built environments.
- 7. In considerations of conclusions 1-6 the Panel considers the proposed development is a suitable use of the subject land and approval is in the public interest.
