# **Determination and Statement of Reasons**

2014SYW144 – The Hills – DA 437/2015/JP [a lot 6 & 5B DP 2123 and 394943, 16-20 Withers Road, Kellyville] as described in Schedule 1.

Date of determination: 29 June 2015

### Decision:

The panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

### Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

# Reasons for the panel decision:

The Panel unanimously approves the deferred commencement approval subject to imposition of the deferred commencement conditions and the general condition recommended in the Council Assessment Report. The reasons for the Panel's decision are as follows:

- 1. The proposal adequately satisfies the relevant State Environmental Planning Policies including SEPP (Sydney Region Growth Centre) 2006 and satisfies the provisions of North Kellyville DCP.
- 2. Having considered the applicants' request to vary the development standard Cl 4.6 of the Growth Centre SEPP the Panel consider compliance with the standard in this case to be unreasonable and unnecessary as the variation does not result in any adverse impacts and the objectives of the relevant zone and the standard are maintained.
- 3. The proposed development will add further housing supply and choice in the developing Northwest Growth Centre in a location planned for this scale of development.
- 4. In consideration of conclusion 1-3 above, the Panel considers the proposed development is a suitable use of the site and approval is in the public interest.

**Conditions:** The approval is subject to the conditions attached to the Council Assessment Report.
