Date of determination: 18 March 2015

#### **Decision:**

The panel determined to approve the development application as described in Schedule A pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

#### Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

### Reasons for the panel decision:

- 1. The proposal development will enhance the social and recreation activities currently provided by the existing licensed club.
- 2. The proposal adequately satisfies the relevant State Environmental Planning Policies including:
  - State Environmental Planning Policy No. 55 Remediation of Land (SEPP No. 55)
  - SEPP Infrastructure
- 3. The proposal adequately satisfies the objectives and provisions of Fairfield LEP 2013 and Fairfield City Wide DCP 2013.
- 4. While the development would, as proposed have a measure of negative impact on the immediate adjoining residences in Leo Street and Cherry Street by removing the three adjacent dwellings and introducing club related service functions abutting the existing residences, the Panel has imposed a condition requiring landscape treatment that will satisfactorily mitigate that impact.
- 5. On consideration of conclusions 1-4, the Panel considers the proposed development is a suitable use of the subject land and approval of the proposal is in the public interest.
