Hi Daniel,

I write with regard to your question below: *"Would Busways envisage using any of the proposed roads as a bus route or would Busways continue to only service Marshall Way?"*

The current bus route, which terminates at the cul-de-sac bulb end of Marshall Way, covers approximately 85% - 90% of this proposed new subdivision – from a *walking-distance-to-bus-route* perspective.

As such we would not propose to deviate the route service off of Marshall Way.

There may be a chance that, depending on the student numbers, a school bus service might use the roads of the new subdivision. This would not however create a demand for indented bus bays or formalised bus stop infrastructure.

I trust that this is helpful with your enquiry, and please let me know if I can be of further assistance with this matter.
