## **Decision:**

The panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

## Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

#### Reasons for the panel decision:

The Panel unanimously agreed to approve the application subject to the conditions in the Council Report, and the additional condition outlined below, for the following reasons:

- 1. To approve the application to modify consent subject to the additional EPA conditions and the Panel agree that the possibilities of any adverse environmental impacts are covered by the Proposed EPA Licence Conditions.
- 2. That the modification will not cause any significant environmental impacts and will assist to implement more sustainable recycling and re-use measures.
- 3. The modification will provide a significant boost to recycling and resource conservation and will facilitate better management of the waste facility.
- 4. The modifications to the original proposal contain a number of significant changes however the Panel believe that they will not result in detrimental impacts in the neighbourhood.
- 5. In consideration of conclusions 1- 4 above the Panel considers the proposed development is a suitable use of the site and approval of the proposal is in the public interest.

#### Conditions:

The application was approved subject to the conditions in the Council Assessment Report and with the addition of the following:

Approval is <u>not</u> granted to the education centre proposed to be located near the push pit. This is to be the subject of a separate Development Application.
