Determination and Statement of Reasons

2015SYE058 North Sydney 128/14/2 [at 2 Anzac Avenue, Cammeray] as described in Schedule 1.

Date of determination: 1 July 2015

Decision:

The panel determined to accept the recommendation of the assessment report to approve the development application as described in Schedule 1 pursuant to section 96 of the *Environmental Planning and Assessment Act 1979*.

Panel consideration:

The panel considered: the matters listed at item 6 as addressed in the Council Assessment Report, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

Reasons for the panel decision:

- 1. The modification application relates to several changes (such as change of material, addition of poster holders and change to the signage) which have no material external impact and are not controversial, so the Panel would have no reason not to approve.
- 2. The only controversial aspect of the application with material external impact is the proposal for a 5.5m X 3.5m screen facing Ernest Street. The Panel has listened to the objectors and considers that the conditions, subject to which the screen is approved, will reasonably mitigate its impact.
- 3. Notwithstanding the above, the Panel believes that the screen could be just as effective, and less disturbing to people living on the other side of Ernest Street, if it were reduced to about 3m X 2m. Given that the Panel cannot impose conditions except with the approval of the Minister, this is not a condition; rather it is a suggestion to the Department that a large screen is not friendly to the neighbours.
