The purpose of this memo is to seek changes to recommended condition 32 and to add two further conditions in relation to Section 94 Contributions as follows:

1. <u>Changes to Condition 32 (Section 94)</u>: The revised condition relates only to the contributions required for Stage 1 and also includes a credit for existing floorspace to be demolished as part of Stage 1 works.

Council also requests to alter this condition by inserting the following wording below the contribution table:

The components of the Section 94 levy that fall both within the category of 'Civic – Urban Improvements' and form part of the works required by conditions 54 and 55, may be offset by works-in-kind in accordance with section 2.9 of the Section 94 Contribution Plan.

This is consistent with_wording added by the JRPP to Council's standard Section 94 condition at the meeting on 15/10/15. It is therefore requested that condition 32 of LDA2015/0214 be amended to read as follows:

32. Section 94 – Stage 1. A monetary contribution for the services in Column A and for the amount in Column B shall be made to Council prior to the issue of any Construction Certificate for Stage 1:
