#### Determination and Statement of Reasons

2015SYE097 – Hurstville - DA2015/0262 - Demolition of existing structures and construction of an 8 storey retail and office development with car parking provided within a stacker system - 9-11 Crofts Ave, Hurstville as described in Schedule 1.

#### Date of determination: 4 February 2016

#### Decision:

The majority of the Panel (John Roseth, David Furlong, Sue Francis and Vince Badalati, with Con Hindi voting for refusal) determined to approve the development application as described in Schedule 1 pursuant to section 96 of the *Environmental Planning and Assessment Act 1979*.

#### Panel consideration:

The Panel considered: the matters listed at item 6 as addressed in the Council Assessment Report, the material listed at item 7 and the material presented at meetings listed at item 8 in Schedule 1.

### Reasons for the panel decision:

The Panel approved the application, by majority, for the following reasons:

- 1. The proposal is consistent with the planning controls in force when the application was lodged. The Panel has accepted a shortfall in the number of cars parked because of the location of the site next to public transport.
- 2. The Panel has accepted car lifts and stacked parking in this case because the site is too small to allow for ramps and a conventional parking layout.

Con Hindi voted for refusal on the grounds that mechanical parking is not suitable as only two cars can queue up, and that one additional parking level should be required to cater for the shortfall in parking.

**Conditions:** The development application was approved subject to the conditions recommended in the planning assessment report.
