Determination and Statement of Reasons

2015SYE124 – Rockdale - DA-2012/293/E - Addition of two (2) levels to Block A fronting Princes Highway and one (1) level to Block B fronting Chapel Lane providing a total of 20 additional residential units and alterations to the building - 564 Princes Highway, Rockdale as described in Schedule 1.

Date of determination: 14 June 2016

Decision:

The panel determined to accept the recommendation of the assessment report to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

Panel consideration:

The panel considered: the matters listed at item 6 as addressed in the Council Assessment Report, the material listed at item 7 and the material presented at meetings listed at item 8 in Schedule 1. The panel adjourned during the meeting to deliberate on the matter and formulate a resolution.

Reasons for the panel decision:

The Panel resolved unanimously that it was satisfied on all aspects of the application.

The proposal, with the inclusion of the two additional storeys on the Highway and one additional storey in the <u>rear</u> applied for in this s96 application, complies with the height control and fits into the desired future character of the Rockdale Town Centre.

The Panel gave consideration to the objections of Ms Jenny Ren and Ms Zhang Xiu Di in relation to overshadowing. The Panel notes that any additional shadow arising from the additional storeys will not make the impact worse in midwinter for the apartments of the two objectors. Moreover, the Panel notes that the site is in a Town Centre zone where expectations of solar access are necessarily reduced.

Conditions: The development application was approved subject to the conditions attached to the Council Assessment Report subject to the inclusion of the conditions required by CASA.
