Decision:

The panel determined to accept the recommendation of the assessment report to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

Panel consideration:

The panel considered: the matters listed at item 6 as addressed in the Council Assessment Report, the material listed at item 7 and the material presented at meetings listed at item 8 in Schedule 1. The panel adjourned during the meeting to deliberate on the matter and formulate a resolution.

Reasons for the panel decision:

The Panel considers that an improved and expanded Roseland Shopping Centre will be of benefit to the area. The Panel has listened to the concerns of objectors. The Panel believes that, subject to the additional condition imposed, the proposal has mitigated the adverse impact on nearby residents to an acceptable level.

Conditions: The development application was approved subject to the conditions recommended in the assessment report, except

- Condition 1, which is a deferred commencement condition, becomes an operational condition, with the timing being "before the submission of a Construction Certificate" and the words "to the satisfaction of council" are added after DCP 2012; and
- A new condition is inserted requiring that the maximum speed on the relocated Roseland Drive be 30 km/h.
