Determination and Statement of Reasons

2015SYW076 – Blacktown City Council, DA 14-2393, Construction of a new fire station, 12 associated car parking spaces and the establishment of a 1,303 sqm bushland protection area, Lot 1 DP 1195719, 1A Ellsworth Drive, Tregear.

Date of determination: 17 June 2015

Decision:

The panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

Panel consideration:

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings (including the applicant's legal advice) and the matters observed at site inspections listed at item 8 in Schedule 1.

Reasons for the panel decision:

- 1. The development provides an essential safety utility serving the new urban settlement occurring in this sector of the metropolitan region, on a site selected to facilitate safe, integrated and time critical responses to emergencies.
- 2. The proposal adequately satisfies the provisions of relevant State Environmental Planning Policies and in particular SEPP (Infrastructure) 2007 which is the planning instrument which permits development of the site for this purpose.
- 3. The proposed development will have no significant adverse impacts on the natural or built environments including landscape character, aboriginal artefacts or the performance of the local road networks.
- 4. The proposal is considered to produce a satisfactory outcome in regard to natural vegetation of habitat management. In this regard the Panel's notes that the large Eucalypt that is to be removed is in poor health and further notes the measures to be taken associated with its removal.
- 5. In consideration of conclusions 1-4 above the Panel considers the proposed development is a suitable use of the site and approval of the proposal is in the public interest.

Decision: The development application was approved subject to the conditions as agreed at the meeting between Council Assessment Staff and the Applicant.
