 to the needs of students with special educational requirements.
- 2. The proposed development adequately satisfies the relevant State Environmental Planning Policies including SEPP 55 Remediation of Land and SEPP (Infrastructure) 2007.
- 3. The proposal adequately satisfies the applicable provisions and objectives of Bankstown LEP 2015 and Bankstown DCP 2015.
- 4. The proposed development is considered to be of appropriate scale and form and adequately consistent with the character of the locality in which it is placed.
- 5. The proposed development, subject to the conditions imposed, will have no unacceptable adverse impacts on the natural or built environments including the amenity of nearby residential premises or the operation of the local road system and the operation of the natural drainage system.
- 6. In consideration of the conclusions 1-5 above the Panel considers the proposed development is a suitable use of the site and approval of the proposal is in the public interest.
