The Chair has requested a memo on the following issues:

- The original report referenced the Coastal SEPP but didn't mention how and if it was zoned under the SEPP or the applicable provisions. Is this the correct document to be referencing given when that application was lodged?
- The Draft Central Coast LEP 2018: is it relevant or does it not apply because of the SEPP?

Response:

State Environmental Planning Policy (Coastal Management) 2018 and State Environmental Planning Policy No 71 - Coastal Protection

The State Environmental Planning Policy (Coastal Management) 2018 into effect on 3 April 2018. The savings and transitional provisions contained within the State Environmental Planning Policy (Coastal Management) 2018 state the State Environment Planning Policy No 71 Coastal Protection provisions continue to apply if a Development Application is lodged and not finally determined prior to the commencement of the SEPP Coastal Management.

An error has been made in the assessment report by referencing *State Environmental Planning Policy (Coastal Management) 2018* as the land does not fall within the maps identifying Coastal Land under State Environmental

Planning Policy (Coastal Management) 2018. In additions, this SEPP would not be applicable given the 1 April 2016 lodgment date and savings provisions detailed above.

The land did fall within land identified on maps for *State Environmental Planning Policy No 71 - Coastal Protection*. However, Clause 1.9 of the *Gosford Local Environmental Plan 2014,* at the time of lodgment, detailed that *State Environmental Planning Policy No 71 - Coastal Protection* does not apply to land within the Gosford City Centre and therefore is not applicable to the current proposal.
