## **MATTER DEFERRED**

2016NTH022 – Clarence Valley – MOD2016/0035 at 242 Faheys & Bulgins Road, Bald Hills, Hernani (as described in Schedule 1)

## **REASONS FOR DEFERRAL**

The Panel agreed to defer the determination of the matter until:

- (a) the completion of the required process of re-notification and exhibition of the Draft Voluntary Planning Agreement (VPA) and advice to the Panel on Council's determination following the outcome of that process;
- (b) the Panel has also considered a further submission from Council following consultation with the Applicant, concerning:
  - (i) potential for management of traffic impacts of the proposal on regular special events in Bellingen, as advised by Bellingen Shire Council;
  - (ii) arrangements for monitoring of quarry truck movements;
  - (iii) the issue of potential overlap between the Draft VPA and provisions of the Roads Act 1993.

## Reasons:

- The amended VPA still required advertising;
- The Panel requires advice on management of traffic impacts on regular special events in Bellingen raised at the meeting;
- Clarification of arrangements for monitoring truck movements from the quarry; and
- Resolution of overlap of provisions of the Roads Act 1993 and the VPA.

When this information has been received, the Panel will determine the matter electronically.

The decision to defer the matter was unanimous.
